This Relief Fund was established by the Chimney Rock Village Council at their Council meeting on October 15, 2024 to raise funds and provide assistance for immediate needs to the residents, citizens, businesses and property owners adversely affected by the storm Helene.

The Candidates who are eligible for receipt of any grant money are those citizens, residents, businesses and other individuals residing in or located within the Village at the time tropical storm Helene damaged the Village and needs necessities, such as groceries, water services, and/or utilities such as electric, housing, healthcare or to protect your property.

Grants in the amounts of \$ 500, \$ 1,000, \$ 2,500 or up to \$ 5,000 will be provided to aid recipients. Grants will be at the direction of the Village Council of who shall receive these special appropriations and the amount of which provided will be determined based on the application for such funds. This distribution will be issued one-time to a recipient unless extraordinary and unique circumstances are evident and in the interest of the Village, a recipient may receive a second allocation to be approved by the Village Council.
